IRA Charitable Rollover

The now-permanent Charitable IRA Rollover provision allows friends of Cathedral High School to reduce their taxable income, achieve charitable giving goals, and satisfy their required minimum distribution – all in one transaction. If you are over age 70 ½, you can donate up to \$100,000 from your IRA directly to Cathedral without triggering any federal income taxes.

Below is language you can use* to notify your IRA Administrator of your intention to make a charitable distribution from your IRA to Cathedral High School via check or wire transfer.
